Executive summary

At the University of Maribor, Maribor, Slovenia, a training course was conducted for management staff titled "Quality Assurance of Doctoral Studies". As part of this training, the University of Maribor engaged key personnel, who were responsible for the development and quality assurance of doctoral studies at the University of Maribor. On the first day, characteristics and methods on how to properly develop PhD study programs were presented. The lectures included practical experience of University of Maribor, while other lecturers discussed the importance of partnership between doctoral candidates, mentors and Universities. The last lecture covered systemic measures of quality assurance at doctoral studies. The first day was closed with a workshop where doctoral students and moderator discussed open questions on development of doctoral school. The financial aspects of the development and implementation of the doctoral study program were also discussed. On the second day, lecturers covered development of doctoral schools at Faculty of agriculture at University of Maribor and use of digital technologies. The day was closed with a workshop and final discussion on open issues. The three-day training was attended by 32 participants, of which 7 were lecturers.

5 Short abstracts

Modern structure of doctoral programmes and experience at University of Maribor

(Prof. Dr. Zoran Ren)

Modern doctoral programs are focused on the comprehensive process of training young doctoral candidates to realize their potentials to become highly proficient researchers in their chosen filed. Individuality, internationalization, interdisciplinarity and intersectoral impacts of their research are foremost orientations of modern doctoral training. To realize this the candidates, have to be properly supervised by scientifically active senior researchers and through the training process equipped both by comprehensive scientific and transferrable skills. A university has to provide appropriate environment and mechanisms to observe and evaluate the training process of each doctoral candidate to assure timely and successful completion of their training. The experiences and observations in changing doctoral studies at the University of Maribor has been shared and discussed in the workshop.

Importance and establishment of partnership doctoral candidate - mentor(s) – University (Prof. Dr. Damijan Mumel)

Interpersonal relationships are an essential dimension of our lives. It is the same in doctoral mentor - doctoral student relationship. In the workshop a discussion of the importance and different dimensions of this relationship has been made.

Systemic quality assurance of doctoral studies

(Prof. Dr. Nataša Vaupotič)

The lecturer presented the formal requirements for the PhD study programmes at the University of Maribor to be approved, the requirements for PhD supervisors, the obligations and rights of PhD candidates and supervisors and the procedures for the thesis approval, its evaluation and defence.

Development of doctoral programmes in agriculture and agricultural economics

(Prof. Dr. Črtomir Rozman)

Historical development, current state of affairs and potential in the field of doctoral study programs of agriculture and agricultural economics has been presented. The basic concepts of studies and related changes with implementation of Bologna reforms have been presented. The emphasis has been put on the interrelation of PhD study programs and regular research work, project activities, profile and employment opportunities of PhD students. Successful case studies have been presented.

Increasing employability of doctorates in emerging sectors with soft skills training

(Irena Lovrenčič Držanič)

This lecture covered the research results of a study, recently completed in several European countries. The main findings presented will be the identification of a set of soft skills that employers demand from doctorates, perceived level of these skills and discrepancies between demanded and perceived skills. Additional discussed topics covered reasons for insufficient employment of doctorates and employers' intention to hire doctorates in future.
