activities on the implementation of the project "Reforming doctoral studies in Montenegro and Albania - a paradigm of good practice" MARDS (Erasmus +) from Montenegro

About the Project:

The University of Montenegro is the coordinator of the regional project "Reforming Doctoral Studies in Montenegro and Albania - Good Practice Paradigm" (Reforming Doctoral Studies in Montenegro and Albania - Good Practice Paradigm). In addition to the University of Montenegro, the project also included the University of Donja Gorica, the Ministry of Education, the Ministry of Science and the Chamber of Commerce, as well as universities from Albania, Croatia, Slovenia, Austria and Slovakia. The aim of the MARDS project is to solve one of the most pressing problems in the Montenegrin and Albanian higher education areas - doctoral studies, which this project will attempt to reform on the basis of the Salzburg principles and the latest recommendations of the European Union. As a pilot example, two joint doctoral schools with headquarters will be established.

The project will review existing national policies / standards for doctoral studies, compatibility with EU practices and propose a new model of doctoral studies in the two countries, adapted to the experience gained over the past decades and current needs. It will also propose a sustainable method of funding doctoral studies in the two countries at national levels.

The project manager from Montenegro is the University of Montenegro and the Chamber of Commerce is a partner in the project.

Activities in 2018-2019

Within the project, in the period of September 2018-2019. The following activities were carried out:

• The first meeting of the representatives of the partner organizations of the project "Reforming doctoral studies in Montenegro and Albania - a paradigm of good practice", MARDS (Erasmus +) from Montenegro was held on September 19, 2018 in the ERASMUS meeting room. The meeting was attended by Radovan Stojanovic from the University of Montenegro, Bojana Malisic from the University of Donja Gorica, Mladen Perazic from the Chamber of Commerce of Montenegro, Biljana Misovic from the Ministry of Education, Jelena Saranovic from the Ministry of Science, and representatives of the ERASMUS + Montenegro office Ms. Vanja Drljevic and Mr. Ranko Lazovic. The meeting was opened and led by the project coordinator from the University of Montenegro, prof. Dr. Radovan Stojanovic, who presented the project and the activities foreseen. The presentation was followed by a discussion explaining the roles and expectations of partner organizations.









- Participation in the meeting on November 30, 2018, at the premises of the Rectorate of the University of Montenegro, where the local coordinators of newly selected higher education capacity building projects from the 2018 competition deadline, met with a representative of the Education, Audiovisual Arts and Culture Executive Agency (EACEA) from Brussels managing the Erasmus + program. The purpose of the meeting was to get acquainted with new projects before the implementation itself began. The meeting also discussed the financial rules applicable to the above mentioned generation of projects, and the EACEA representative introduced the participants to the project and financial management. The projects of the Chamber of Commerce of Montenegro are 598465-EPP-1-2018-1-ME-EPPKA2-CBHE-SP "Reforming doctoral studies in Montenegro and Albania good practice paradigm". Aleksandar Marđonović participated.
