1st Year Report University of Vlora "Ismail Qemali"

The REFORMING DOCTORAL STUDIES IN MONTENEGRO AND ALBANIA – GOOD PRACTICE PARADIGM (MARDS) project addresses one of the most acute problems in Montenegrin and Albanian education systems, the doctoral studies. The main aim of the project is to reconstruct doctoral studies in line with Salzburg Principles, establish sustainable funding mechanisms in this area and introducing two modern Pilot Joint Doctoral. This will serve as an example of good practice for the WB Region. The project is funded by the European Commission (Grant: 598465-EPP-1-2018-1-ME-EPPKA2-CBHE-SP) and started at the beginning of 2019. During the previous year the project partners have worked hard and reached almost all their goals. University of Vlora (UV) is a key partner at this project and has contributed significantly in fulfilment of the objectives during the first year. In general, UV members have prepared documents, participated in training and quality assurance activities, participated in the conference about doctoral education, completed questionnaires asked by Work Package leaders, disseminated the project etc.
